The following are required to be filed / deposited along with the Enrolment Application.

1. The Name and Address in the enrolment form is to be filled up in Block Letters
2. Attested copy of LL.B. Certificate (Provisional) issued by the University .
3. Attested copy of H.S.L.C./ equivalent certificate issued by the Board / University.
4. Two Certificates in original from two advocates of ten years standing about applicant's Character, ability for enrolment & Nationality.
5. Attested copy of the certificate from the competent authority, if applicant is a member of Scheduled Caste / Tribe.
6. Attested copy of the certificate of the Principal of the Law College in which he / she had prosecuted the study of law.
7. Attested copy of Graduate or any other equivalent degree Certificate issued by the University.
8. Nationality (To be supported by an Affidavit).
9. Two Bank Drafts (Mandatory) -
 - a) Of Rs. **4800/-** (for General and OBC) and (Rs. **2400** for Scheduled Caste/ Tribe Candidate) draft in favour of the **Bar Council of Assam etc .**
 - b) Of Rs. **1200/-** (for General and OBC) and (Rs. **600** for Scheduled Caste/ Tribe Candidate) draft in favour of the **Bar Council of India.**

Draft to be drawn on Guwahati Branch of any Nationalised Bank.

10. Rs. 3000/- in Cash / Draft in favour of Bar Council of India Advocates Welfare Fund Committee for the State of Assam as contribution for life towards Advocates Welfare Fund along with a signed Form under Rule 40, to be collected along with the Application Form.
11. Rs. 5250/- in Cash / Draft in favour of Bar Council of Assam, Nagaland, etc. towards Development fee, Establishment fee, Administrative cost and Identity Card fee for fresh Candidates and Rs. 8250/- for Candidates other then fresher.
12. Rs. 1000/- in Cash or Draft in favour of Bar Council of Assam, Nagaland etc. towards the cost of Enrolment Form. Draft to be drawn on Guwahati Branch of any Nationalised Bank.
13. Rs. 2100/- in Cash / Draft in favour of Assam Advocates' Welfare Fund only for the applicant of Assam as contribution for the towards Assam Advocates' Welfare Fund along with a signed form under Section 15 for Admission as member of the Fund.
14. Three copies of recent passport size photographs of the Applicant - one copy to be attested by Notary or by a Gazetted Officer and the other two self attested.
15. If in service, order of release from the competent authority, If engaged in any trade or other avocation or employment, an affidavit declaring abandonment of the same.

Enrolment Committee may require further materials / affidavit to ascertain the eligibility of the applicant for enrolment. A further affidavit declaring that he/she obtained LL.B. degree by attending classes regularly to be submitted.

16. To submit an affidavit stating that all the documents annexed to the Enrolment Application are genuine and correct.
17. To collect Enrolment Certificate & I Card by an authority person on behalf of the applicant, please ensure that the authorized person shall bring an authorized letter signed by the applicant along with the ID proof of that person.
